### CTGCA Ally, Fund Her, Launches

Fund Her will join the womenforward alliance seeking

Gov. Brown signed these common-sense laws that benefit and protect the economic security of women and the communities in which they live:

<u>Employers: Salary History Information:</u>
AB 168 (Eggman)

AB 168 prohibits employers from seeking salary history information from applicants and requires most employers to provide the pay scale for a position to an applicant upon reasonable request.

## <u>Unlocking Opportunities for Families Bill:</u> AB 273 (Aguiar-Curry)

Parents seeking ESL and GED training qualify for child care assistance under AB 273, empowering them to increase their educational level and supporting their children's healthy development. Woot!

### New Parent Leave Act: SB 63 (Jackson)

Under previous laws, only employers with 50 or more employees were required to provide parental leave. SB 63 protects crucial bonding time for even more Californian parents by expanding the class of employers who must provide parental leave to employers with 20 or more employees. What's more, this fantastic new law also protects their health care coverage during parental leave.
