#### **CREATING A PATH OUT OF POVERTY**

Assemblymember **Cecilia Aguiar-Curry's** (D-Winters) bill, AB 273, "will help Californians who are pursuing English-language education or a High School Equivalency certificate receive state assistance for childcare services." (details)

"Assemblymember **Anna Caballero** (D-Salinas) introduced AB 225, which will allow more working families to qualify for the Cal EITC. The bill will open eligibility to full-time minimum wage earners and will also adjust the minimum wage increase through 2020." (details)

Hundreds of thousands of people will converge on Washington, DC this weekend for the People's Climate March. **Rachel's Network** will be working to train hundreds of pro-environment women to run for office the following day.

What: Run to Win 101 – Environmental Candidate Training When: Sunday, April 30, 9 a.m. – 1 p.m. Assemblymember **Laura Friedman** introduced a bill in response to the current ratio preventing physicians from supervising more than four nurse practioners. "AB 1560 eliminates the ratio, easing access to quality health care, particularly in underserved communities." (details)

"This bill [AB 557, introduced by Assemblymember **Blanca Rubio**] would instead require a county to waive a CalWORKs program requirement for an applicant or recipient who is a past or present victim of abuse when the program requirement, if not waived, would place the family at risk of harm, unfairly penalize the family, or make it more difficult for the family to escape abuse." (details)

#### PROMOTING TRANSPARENCY AND OPPORTUNITY

"AB 162 [introduced by Assemblymember **Sabrina Cervantes**] would make more small businesses eligible for the California Competes tax cut.... The tax cut is available to small businesses that wish to establish a business, or stay and grow an existing business, in California." (details)

"In order to provide more transparency and accountability to the public, Assembly Bill 1328, a bill by Assemblymember **Monique Limón** (D-Santa Barbara), requires quarterly disclosure of chemicals used in oil and gas operations, just passed its first legislative hurdle in the Assembly Natural Resources Committee..." (details)
